**ORDINANCE DESIGNATING THE POST
STANDARD AS THE OFFICIAL NEWSPAPER OF
THE CITY OF SYRACUSE FOR 2020 AND 2021**

BE IT ORDAINED, that pursuant to the provisions of Section 3-109 of the Charter of the City of Syracuse – 1960, as amended, the Common Council hereby designates the Post-Standard to be the official newspaper of the City of Syracuse for the years 2020 and 2021 for line ads and display ads at the daily rates and subsequent daily insertion rates detailed in the Rate Schedule attached hereto as Exhibit “A”; and

BE IT FURTHER ORDAINED, that said newspaper shall be deemed the official newspaper for years 2020 and 2021 at the rates provided herein unless the rates are changed by the New York State Legislature during said period.
