

**RESOLUTION AUTHORIZING THE USE OF PERSEVERANCE PARK FOR A YOGA FUNDRAISER**

**WHEREAS**, by email dated August 19, 2016 and attached to this Resolution as Appendix "A" (hereinafter the "Email"), Lauren Cirulli, events coordinator for Cuse Pit Crew a/k/a Cuse Pit Crew, Inc. (hereinafter "Cuse Pit Crew"), has requested on behalf of Cuse Pit Crew that the Syracuse Urban Renewal Agency (hereinafter "SURA") permit the use of Perseverance Park (Tax ID# 104.-27-02.1) (hereinafter the "Park") for a "Bend and Zen" yoga fundraiser (hereinafter the "Event") on September 24, 2016 from 10:00 a.m. to 11:00 a.m., or at another date and time mutually agreed upon by Cuse Pit Crew and designated SURA staff; and

**WHEREAS**, Cuse Pit Crew shall be insured for the Event and shall list SURA as an additionally insured party upon terms and in amounts that are agreeable to SURA's Chair and SURA's Counsel; and

**WHEREAS**, SURA is the owner in fee of the Park; and

**WHEREAS**, SURA desires to facilitate the Event to take place at the Park as described in the Email; and

**NOW THEREFORE, BE IT RESOLVED**, that SURA hereby authorizes the use of the Park for the Event upon such terms and conditions as contained in this Resolution, the Email and such other conditions that SURA's Chair and SURA's counsel deem necessary and proper; and

**BE IT FURTHER RESOLVED**, that SURA's Chair is authorized to execute an agreement with Cuse Pit Crew for the use of the Park for the Event, the final terms of the agreement to be satisfactory to SURA's counsel and approved by SURA's Chair; and



**BE IT FURTHER RESOLVED**, that any documents necessary to implement this Resolution shall be in a form that shall be satisfactory to SURA's counsel; and following such approval by counsel, SURA further authorizes its Chair to execute said documents on behalf of SURA.
